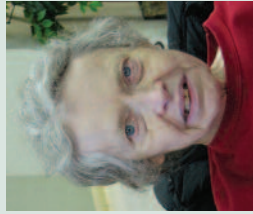

An abundance of individual and organizational volunteers have helped keep our homes in good repair and looking great through many hours of painting and lawn care. A special thanks to Bailey Nurseries for their generous contribution of plants used for landscaping at Wingspan locations.

# Home Again

When the H1N1 virus struck Michelle, she nearly died from complications. At the end of a three-and-a-half-month hospitalization, she returned home to her housemates at 16th Avenue without the use of her arms and legs and unable to care for herself as she had before.

But it didn't take long for Michelle to get back in the swing of things, thanks to determined Wingspan staff and Michelle's own drive. Accommodations were made to the house, home care equipment was brought in, and staff learned how to care for Michelle's new needs. A huge help was a new wheelchair-accessible van, underwritten by Wingspan donors, which not only transports Michelle to medical care and therapy but makes more excursions possible for everyone at 16th Avenue.

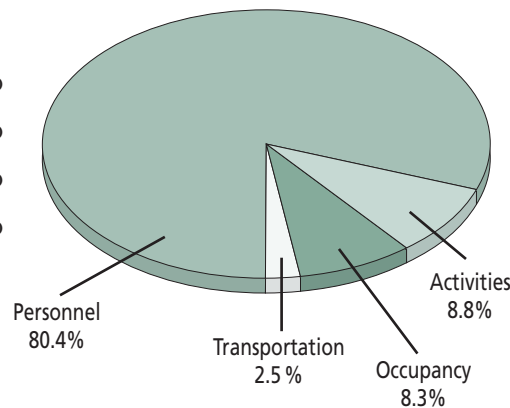
